Request:

 A breakdown of all costs incurred by Irish Rail (between January 1, 2008, and April 3, 2019) in respect of Westmeath County Council's proposed development of the so-called 'Railway Field Road', adjacent to the Crescent junction, in Athlone.

This breakdown should include, but is not limited to, all design costs, legal fees, consultants' fees, arbitration costs and land transfer costs incurred to date as a result of this proposed development.

The appeal will involve a complete reconsideration of the matter by a more senior member of the staff of this body.
