# FIELDREACH WORK MANAGER

Please find below issues with the fieldreach work manager app that have been discovered while carrying out live intermediate inspections.

### **GENERAL QUERIES:** (All To be discussed between the ACM team)

- "Does the asset pose a risk to the public?", "Does the asset pose a risk to IE Staff?", "Does the asset pose a risk to a 3<sup>rd</sup> party?", "Does the asset pose a risk to track?".
  Will we be asked these questions each year or can the answers to these questions be recorded this year and not asked again next year?
  We could possibly be asked these on a 5 year cycle?
  It should be made clear what these questions mean. This may require rewording. Where the answer is 'Yes', this does not mean there is a current known risk or fault associated with the equipment. This refers to the proximity of the equipment being surveyed relative to the user group i.e. public/staff/track/3<sup>rd</sup> party.
- Should there be a script for signage?
- Platform areas.

This is not simply a length x width exercise as platforms are not all a uniform width. This could be calculated on the asset data maps?

# **GENERAL QUERIES:** (For IAMS Team)

- "My work log" on the app only shows very recent inspections.
   Can this be changed to show all inspections that have been closed out? A filter option would work well here if possible.
- Is it possible to log a P3/P4 fault against an equipment after the workorder has been closed out? Or do we have to log additional P3/P4 faults through sharepoint?
- How do we add a building to fieldreach? Through service request?

#### **APPROACH ROADS:**

- "Is there <u>are</u> approach road present at the functional location?" Typo shown in bold. Also, is this question needed if the approach road has already been confirmed? For example, If there is a script in place for approach roads then it is already confirmed that an approach road is present.
- Add the question "Footpath present?". If answer is "yes" then a series of questions to be asked relating to the footpath.
   At the moment it asks "The material used to construct the approach road attached footpaths" followed by the question "Is there kerbing provided between the footpath and approach road?".

### CAR PARKS:

- "Total number of car park spaces?".
   Does this include all spaces including disabled, E-Bays etc?
- What is the difference between "Any access ramps?" and "Maintenance Access Ramp?".

#### FOOTBRIDGE:

- \*\*Alan. Can you add the agreed wording for the rise, going & width for the stairs here please?\*\*
- "Gradient measurement of the ramp access?".
   Should we just enter "0" if there is no ramp present?
- "Is the footbridge compliant with current standards and regulations?"
   Does this question relate to every element of the footbridge including tactile or is it just in relation to the rise, going, width and handrails?

# **FURNITURE:**

- Are we including shelters under the heading furniture on the app?
- Would platform shelters be considered "permanent"?
- Would shelters be considered "non corporate" or "N/A"?
   What is the difference between corporate and non corporate furniture?

# **GATES:**

"Type of height barrier". If there is no height barrier, we need the option of "N/A" so we can complete the script.
