OCS security officers operate on that rail line, but they do not specifically patrol this car park unless a problem is raised. OCS/Manguard are responsible for the opening and closing of this car park in the morning and night times. Kaiser Parking have an attendant in place at M3 Parkway, and this person can alert the Gardaí if and antisocial behaviour is encountered.

There is a lease agreement in place with Kaiser Parking for the rental of 750+ car parking spaces for a Major American Multinational client based in Leixlip.
