And it is our opinion that "granting the request would, by reason of the number or nature of the records concerned or the nature of the information concerned, require the retrieval of a number of records or an examination of such kind of the records concerned as to cause a substantial and unreasonable interference with or disruption of work" of the Dart West project.

I refer to the appeal which you made under the Freedom of Information Acts 2014 and our acknowledgement letter dated 13th June 2022. I apologise for the delay in replying.

I am a more senior member of staff in larnród Éireann, than the original decision maker in this case. I have decided today 4th August 2022, to affirm the original decision made in relation to your request. This review of your request is an entirely new and separate decision, and is explained as such below.

Your request was refused under Section 15(1)(c) of the Freedom of Information Act 2014 in that it potentially relates to a significant number of records, including emails, meeting minutes, letters, etc., requiring search and retrieval, and subsequent assessment. The decision stated that in our opinion "granting the request would, by reason of the number or nature of the records concerned or the nature of the information concerned, require the retrieval of a number of records or an examination of such kind of the records concerned as to cause a substantial and unreasonable interference with or disruption of work" of the Dart West project.

Your original request, sought access to the following records:

All communications (up to and including those in relation to this request) between Irish Rail (including, but not limited to, those involving the DartWest team) and the National Transport Authority (NTA) in relation to the DartWest project. These communications should include those with **Deputy**, Deputy Chief Executive of the NTA

I am satisfied that the refusal was a reasonable one, given the extended timescale over which the project has been in development and detailed engagement with the NTA. The project is aligned with public policy, including national and regional transport and climate action strategies, and the potential number of nature of records could indeed cause a substantial and unreasonable interference with or disruption of work of the Dart West project.
