Please be advised that Kishogue has been closed during the period outlined above. Therefore, no money has been spent on refurbishment or maintenance for this period. However, existing services have been vandalised and, in most cases, de-energised due to asset condition. The existing lifts will not be modernised until a future decision for Kishogue, as well as funding have been approved for the replacement services.
