The other stations on the Mayo line do not keep a record of what is lost/found.

All stations have a place where they put anything that is found and if anyone comes looking for an item, the staff then check if the item was handed in.

Anything of value such as phones/wallets are kept in the safe.

The Station Manager Athlone has recently set up a system whereby the staff member fills in a form describing what is handed in.

There is no formal system in place for lost property.
