


I have spoken to **a second second**, and can confirm that currently there are no plans to reopen Dunleer Station in the foreseeable future.

For information, in 2013 funding was made available under the current capital programme to make safe the roof and adjacent brickwork to provide protection to same as a mitigation issue for the maintenance of the building. This was done in consultation with Louth Co. Council Conservation Officer. Our Building & Facilities Management and Architectural support met with their Conservation Officer on site on 19th April to discuss Conservation Methodology and proposed Plan for this structure

Presently we do not have funding to undertake extensive remedial works as the building is of a non operational use and all budgets are being utilised to fulfil the safety needs of live railway premises.

I refer to your letter of 06 May 2014 in which you make representations on behalf of Mr. with regard to the re – opening of Dunleer train station.

As Minister for Public and Commuter Transport I have responsibility for policy and overall funding of public transport. Matters relating to the re – opening of railway stations, such as at Dunleer, are a matter for larnrod Eireann in the first instance.


I understand from Iarnrod Eireann that there are no current plans to re – open the station at Dunleer. As you will be aware, CIE is in a difficult financial position and is dependent on continued bank funding. It has no resources of its' own available to fund new projects and no such proposal has been made to either this Department or the National Transport Authority. The lifetime of this Governments' Capital Investment Plan runs to 2016 and within that capital plan the priority is to protect the operational network and maintain safety standards, rather than the opening of new stations.

Consideration of a new Government Capital Investment Plan beyond 2016 has begun and consideration can be given to this matter within that. However, this will depend on the overall funding made available to transport for all modes, and within that, the funds made available for heavy rail. The priority for heavy rail post 2016 will be, as at the moment, the protection of the operational network and the maintenance of safety standards. If there are additional funds after that – and this is not certain - there will be competing demands between the opening of new lines, the improvement of existing lines, rolling stock upgrades, the upgrade of in – use train stations and the opening of new stations in different parts of the country.

All of these competing demands will be subject to robust analysis and will require strong business cases justifying their value as well as a demonstration of their potential to significantly increase patronage on the rail network.

# Dunleer – June 2014

Iarnród Éireann currently has no plans to develop a railway station at Dunleer, nor is there currently any funded third-party proposal for such a development.

larnród Éireann's policy is that new stations should be externally funded, either as part of the Exchequer-funded capital investment programme or through private development contributions.

While no specific business case has been developed for Dunleer, it is believed to be highly unlikely to generate the required return on investment to justify inclusion in Exchequer-funded investment programmes. > Our letter is a result of a recent meeting with the committee of Stop@Dunleer... The sole objective of this group is the re-opening of Dunleer Railway Station. As it is a stated objective of the County Development plan, their aim is to revive this local connection, at the centre of a 40km stretch of non-stop rail track - the longest unserviced distance between Irish Rail stations, on this important economic Dublin-Belfast corridor. This region is forecast to have 60% of the population of the island, and produce more than 70% of the GDP by 2020, as predicted by a DCU report by Prof Brian MacCraith.

>

> Ever since the station shut its doors in 1984, there have been calls for its re-opening. To give some of the background and reasoning for this contemporary ambition, we want to refer to its' inclusions in many commended reports, studies and plans over the past 15 years.

>

> In 1999 An Taisce the National Trust for Ireland compiled and launched an Urban Design Strategy, supported by Louth County Council, the Heritage Council, the School of Architecture University College Dublin and the Dunleer community. Therein the potential value of the Train Station was recognised.

> In 2003 a Scoping Study for the Regeneration of the Rail Corridor Area between Drogheda and Lurgan was compiled by Environmental Research Management on behalf of Mourne and Newry District Council, Craigavon District Council and Louth County Council. The report recommended to Louth County Council that it continue to work towards the reopening of Dunleer Station.

> The Louth County Development plan 2003-2009 stated on page 128 under policy P 8.4 "to seek the reopening of Dunleer railway station."

> The 2010-2016 Louth County Development Plan on page 163 under policy TC19 "To secure, in co-operation with Iarnród Éireann, improved rail services in County Louth, particularly for the mid and south Louth areas."

> Some facts as are recorded. When the development pressure was at it's height in 2006 a planning application was submitted to develop lands adjacent to the station with no regard for the potential reopening of the facility, even though it was a clearly stated objective of the County Development Plan. Subsequent to three appeals by An Taisce, a prescribed body under the planning acts, all appeals were upheld by An Bord Pleanala. This was primarily because the proposed developments would prejudice the reopening of the train station.

Louth Local Authorities remain committed to reinstating rail travel for the mid-Louth area and effectively the re-opening of the railway station in Dunleer or another location serving mid-Louth would prove a significant resource to the town and the surrounding hinterland.

>

> Policy, IN 21 To encourage rail use as a sustainable mode of transport and to promote the reopening of the rail service to the town and to ensure the future protection of lands adjacent to the railway station from inappropriate development that could jeopardise the long term likelihood of the reopening of the rail station.

> The Mid Louth area is the home of 60,000+ people, - that is the population catchment potentially able to travel to Dunleer station more efficiently and quickly than either of the other local options, with less interruption to traffic in Drogheda or Dundalk. With Dunleer station re-opened, we estimate that at least 200

cars would be taken out of each of these towns at rush hour times each day.

>

> In this relatively compact region we have some of the most internationally recognised indigenous industries -Kingspan, Suretank, Anglo Beef Pkg, Glen Dimplex; successful export led industries and global leaders in their fields, these are expanding companies who require the best employees to sustain their continued success. Making this region more accessible can only aid this aim, and promote all local economic sectors, including sensitive and sustainable development of the area.

>

> The best and the brightest need education options. There are ten third level institutions on this corridor accommodating over 150,000 students. The residents of Mid Louth and beyond deserve the chance to be able to choose their third level education college options, and a local train station would allow for this wealth of choice.

> This is also a quality of life issue - a social issue. Train travel is pleasurable and efficient - people can work on the train, it is reliable and rarely affected by weather. However, for reasons of economic, social and environmental sustainability, rail is endorsed and promoted by the European Commission. It is recognised that there is a social dividend pay back. The TEN-T programme has a budget of EURO 26bn between 2014-20, with the objective to promote growth and expansion in both passenger and freight transportation. For all the reasons stated before, the Commission has plainly been very active in restructuring the European rail transport market and strengthening the position of railways vis-à-vis other transport modes.

> So our proposal is not only practical today, but prescient and sensible for the future.

> We the undersigned as members of Oireachtas, in support of the Stop@Dunleer initiative, ask of the Minister for Transport to allocate resources to research and attain funds that are available to assist in this widely supported objective. 





To ask the Minister for Transport if he will request full feasibility studies to take place on the opening of a much needed train station on the north of Viaduct Drogheda, County Louth and the reopening of Dunleer train station in mid-County Louth in advance of the imminent DART expansion to Drogheda both of which would further decrease the need to use private vehicles in the county and help meet carbon targets; and if he will make a statement on the matter.

As you can appreciate larnród Éireann receives many requests for both new greenfield stations and disused stations to be re-opened throughout the network.

The delivery of any new rail infrastructure necessarily involves a multi-agency approach in the planning, design, funding and construction of a scheme. There are also strict Government enforced conditions in place surrounding the release of funds for capital infrastructure projects which must be adhered to by all agencies wishing to draw down public funds. These are set out under the Public Spending Code drawn up by the Department of Public Expenditure and Reform.

In general, therefore before larnród Éireann can receive public funding to proceed with any rail infrastructure scheme the following conditions must be met;

- the proposal must be fully supported by relevant transport strategy & planning policy (National Transport Authority /Department of Transport/An Bord Pleanála approval as required)
- the proposal must have a robust Business Case in line with current Government Public Spending Code & sector specific Common Appraisal Guidance for transport related projects (available from the Department of Transport website)
