### IE\_FOI\_405 Response letter

#### Response:

I, Louise O'Riain, Decision Maker have now made a final decision to refuse your request on 12<sup>th</sup> January 2021.

As is explained below, this decision is made under FOI Act 2014 Part 1 Section 2(1) (c).

All the documentation is pre-2008 so is outside the scope of the FOI Act 2014 Part 1 Section 2(1) (c) "in the case of an entity that immediately prior to enactment of this Act, was not a public body within the meaning of the Act of 1997, but is a public body within the meaning of this Act, 21 April 2008, unless provision is made to the contrary by order under section 6".

#### Rights of appeal

The appeal will involve a complete reconsideration of the matter by a more senior member of the staff of this body.
