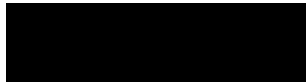

Figure 1: Navan Line Re-opening, Routes Considered at Scoping Stage (2008)

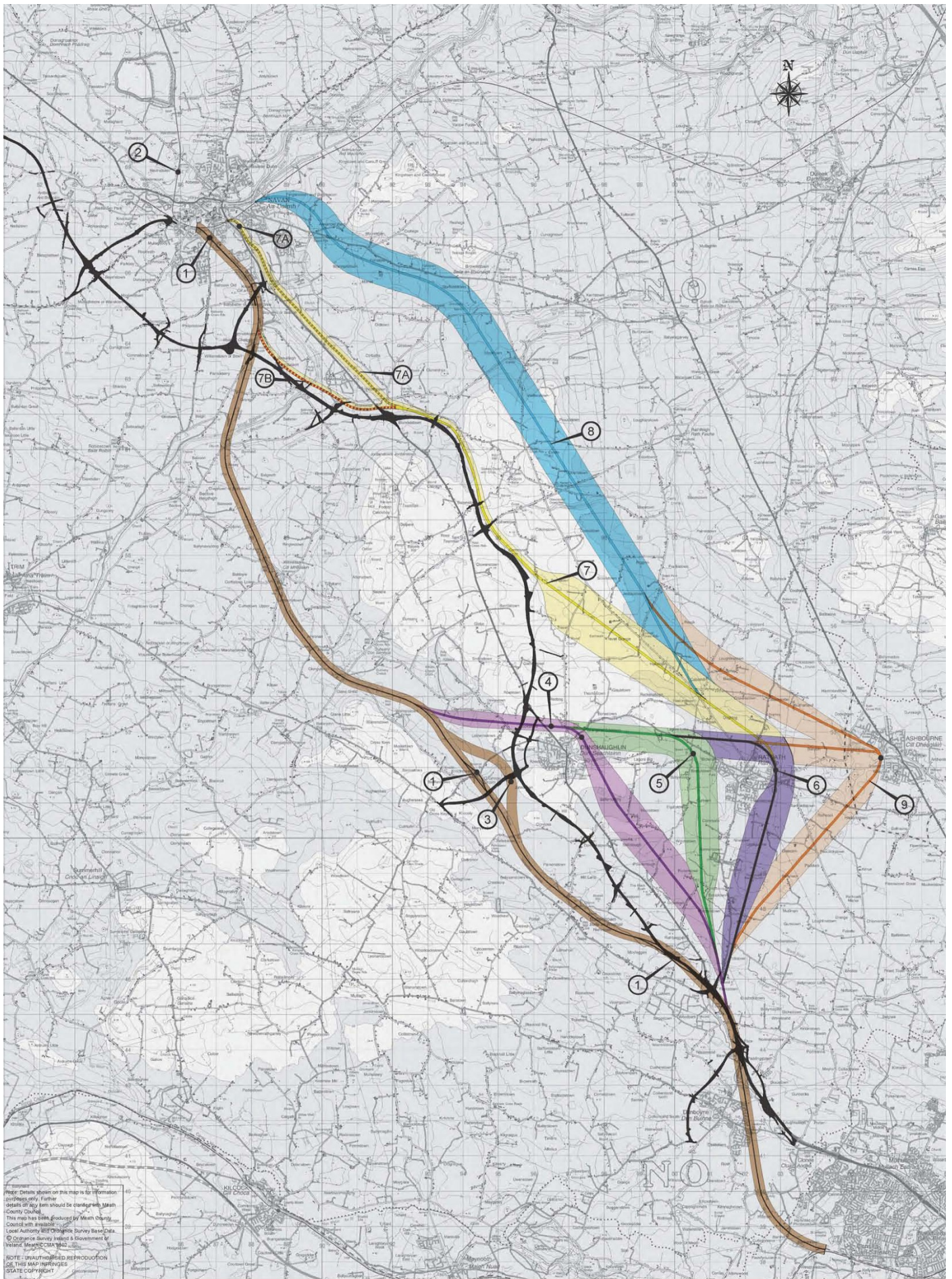


Figure 2: Navan Line Re-opening, Routes Considered at Feasibility Stage (2009)

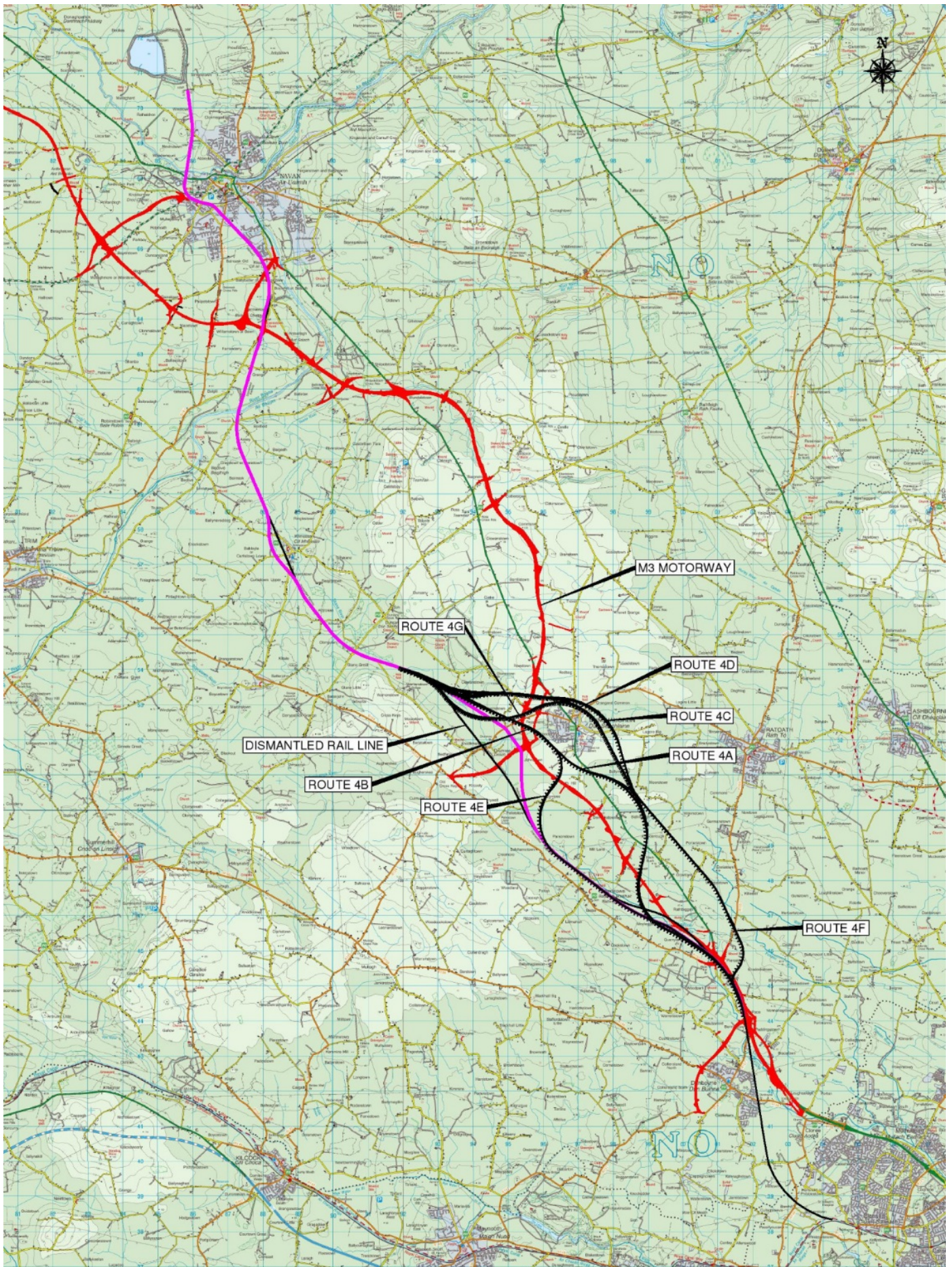


Figure 3: Navan Line Re-opening, Preferred Route (2010)
