• History of night time track works since 2017 at Donabate Train Station to include the length of works and number of machines on site.

larnród Éireann have an ongoing continuous requirement to carry out maintenance work on the railway network, typically at night. Night work is essential as the works, by their nature, cannot progress whilst trains are running. These works include (but not exclusively) placing ballast, packing the track, vegetation management, structures maintenance, etc. The length of time spent on these works is dependent on the track possessions (times when trains are not operational) and on the Dublin to Belfast line these are typically 4 hours on a mid-week night and 6 hours on a Saturday night

To examine all "night time track works history since 2017 at Donabate Train Station to include the length of works and number of machines on site", will take a lot of time and effort, and a search and retrieval fee of approx. €480 will apply. Please notify the FOI department if you wish to pay this fee and proceed.

• Reason for vegetation control which has been done in September

The removal of vegetation in September was required for safety reasons to remove the potential for low rail adhesion, which is linked to leaf fall.

• Reason why the number of trees has been cut in half

larnród Éireann try to minimise the amount of vegetation removal to the absolute minimum necessary to maintain a safe railway, hence we lop trees rather than fully remove if at all possible
