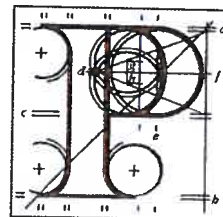


Further advice or details in relation to the above will be provided by the Board at pre-application consultation meetings (if held).

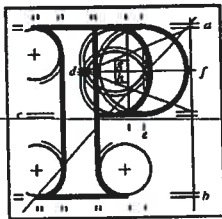
