Please note that IE operates a qualification system for the supply of "Static/Mobile welfare units, this was advertised in the European Journal under reference 2018/S 058-128995 and is open to applications until 11th April 2022 or until it is replaced or cancelled. The criteria for qualification includes relevant experience in the supply, delivery and installation of static and self-contained welfare facilities, company technical resources, quality, environmental and safety management in order to ensure that only experienced providers would be invited to tender or quote for the supply of this type of product.

I, [REDACTED], Decision Maker have now made a final decision to grant your request on 2nd January 2020

Below is the record of all transactions involving the purchase rental of portable buildings (Kabins/cabins) during 2018 and 2019.

1. Temporary hire – these are considered as temporary dwellings and are exempt from Part L of the building regulations under Class 12 or class 13 of the third schedule of Building Regulations 1997 SI 497. Mostly temporary welfare facilities/ site huts.
