Please find below details of larnród Eireann's annual census for 2013, 2014, 2015 and 2016 for Shankhill DART station;

2013 - 2,161 passengers

2014 - 2,134 passengers

2015 - 2,587 passengers

2016 - 2,645 passengers

The annual census measures boarding's and alighting's at Shankhill DART station on a specific commuting day in November of each year. These numbers are a good approximation for annual footfall.

The 2017 Census is taking place on 16th November with draft results available shortly thereafter.
